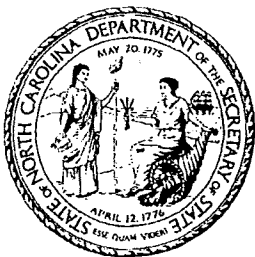

Pursuant to North Carolina General Statute Section 55A-11-04, the undersigned entity does hereby submit the following Articles of Merger as the surviving nonprofit corporation in a merger between two North Carolina nonprofit corporations.

1. The name of the surviving entity is **Cannon Memorial Young Men's Christian Association**, a nonprofit corporation organized under the laws of North Carolina.
